







## Important Regulations on Standards for Qualification Agreements ("Tenure Requirements")

From the perspective of organizational regulations employees who have successfully completed a qualification agreement are to be classified as full professors.

Besides the below specified requirements with regard to research, qualification agreements contain requirements regarding teaching (in terms of quality and quantity) and outreach/citizenship behavior (specified individually).

The *minimum standards for qualification agreements with regard to research* at the Department of Strategy and Innovation are defined by the following two requirements:

- (1) Successful completion of habilitation proceedings. To achieve this, candidates are expected to publish a total of five articles, all of them at least at the level of B-rated publications based on the VHB ranking.
  - The requirements for successful completion of habilitation proceedings are defined in more detail in the Senate Habilitation Directive in the WU By-Laws and in the department's own habilitation directive.
- (2) For successfully completing a qualification agreement the following additional minimum requirements apply:
  - (a) At least two of the five articles required for completion of habilitation proceedings must have been accepted for publication in A+ journals (according to the VHB ranking or the WU Star Journal List).
  - (b) Apart from these two A+ articles, at least one further paper must have been accepted for publication in a journal rated no lower than A (according to the VHB ranking).

From the three articles specified in items (a) and (b), at least one must be a single-author publication, and none of the five required publications must have more than the usual number of authors for international publications in the respective discipline (max. three authors; only one of the articles may have four authors).

All five publications must be no older than ten years (calculated from the year of publication), and at least two of the five articles must have been published or accepted for publication during the qualification agreement period. Papers are only accepted if they are regarded as proper academic articles by the scientific community (i.e. no editorials, replies to other contributions, book reviews, or similar papers). The articles are evaluated based on the versions of the relevant journal rankings in effect at the time of conclusion of the qualification agreement. In the case of older articles, the papers may also be evaluated based on rankings that were in effect at the time when the paper was accepted for publication, if this results in a higher rating.
