

# Heuriger 10er Marie



The "**10er Marie**" is the oldest wine tavern in Vienna, first mentioned in 1740!

The heritage protection house is since 1993 owned by the family Fuhrgassl-Huber. Fine wine tavern tradition is maintained, many prominent guests stayed here for good times - even today is the "10er Marie" meeting place of prominent artists and politicians.

### Reachability by public transportation:

We're going together to the Heurigen "10erMarie", departure from WU (in front of LC) is around 5:00 p.m. For all those, who like to come individually there is a description to the location below.



Take underground U2 and U3 (from Messe-Prater (U2) to Volkstheater (U3) to Ottakring and get off at the final stop in **Ottakring** and walk the last few metres, which takes about three minutes.

or

Take underground U2 and Tram-Line 44 (from Messe-Prater (U2) to Schottentor (Tram 44) to Maroltingergasse and get off at **Johannes-Krawarik-Gasse** and walk the last few steps.
