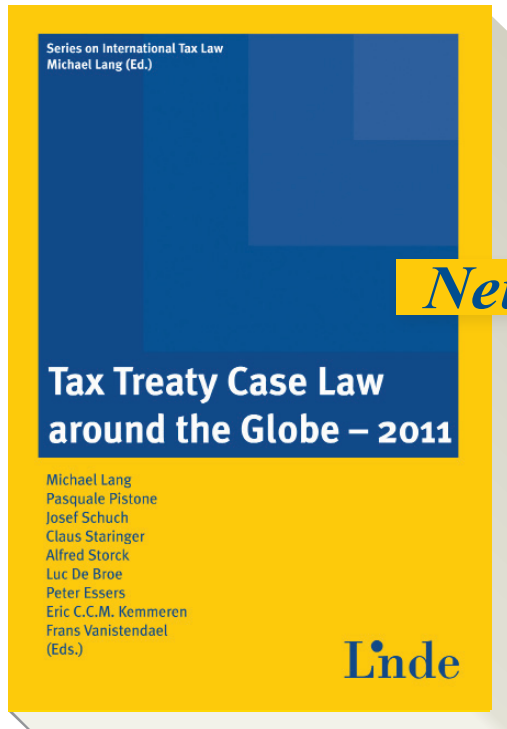


Tax Treaty Case Law around the Globe –2011
