WHICH TYPES OF PERSONAL DATA ARE PROCESSED?

We process the data you provide to us during registration, such as your last name, first name, gender, nationality, and email address.

FOR WHICH PURPOSES DO WE PROCESS YOUR DATA?

The above-mentioned data are processed for the purpose of organizing and conducting the preparation days for the selection procedure of BBE.

WHAT IS THE LEGAL BASIS FOR PROCESSING YOUR DATA?

- Art. 6 (1) item a GDPR – consent

The consent can be withdrawn at any time with effect for the future. The withdrawal of consent does not affect the lawfulness of the processing of your data carried out on the basis of your consent until the withdrawal.

DOES THE PROCESSING INVOLVE ANY AUTOMATED DECISION-MAKING (INCLUDING PROFILING)?

The processing of the personal data does not involve any automated decision-making.

ARE YOU OBLIGATED TO PROVIDE YOUR PERSONAL DATA?

Participation in the preparation days is voluntary. If you wish to participate, we rely on you to provide us with your data.

TO WHICH OTHER PARTIES DO WE PASS ON YOUR DATA?

We do not share your data with third parties.

HOW LONG DO WE STORE YOUR DATA?

We will delete your data after the completion of the preparation days.

WHAT ARE YOUR RIGHTS AS A DATA SUBJECT?

As a data subject in the context of these data processing operations, you have the following rights vis-a-vis WU as the controller: information and access, rectification, deletion, restriction of data processing, data portability, and objection. As a data subject, you also have the right to file a complaint with the Austrian Data Protection Authority.
