- Transfer of your personal data insofar as you have provided it to you or a third party in a structured, common and machine-readable format.

In addition, you have the right to revoke your consent at any time vis-à-vis the controller, with the consequence that the processing of your personal data, in accordance with your declaration of revocation, by the controller becomes inadmissible for the future. However, this does not affect the lawfulness of the processing carried out on the basis of the consent until the revocation.

#### **Appendix: Definition**

• *"Controller" means,* pursuant to Art. 4(7), the natural or legal person, public authority, agency or other body which alone or jointly with others determines the purposes and means of the processing of personal data. In connection with surveys (interviews) for scientific work (bachelor's theses, master's theses, dissertations), this is the author(s) of the work in question and not the department or institution at which the work in question is written and/or submitted and/or reviewed.

• *"Personal data" means, in* accordance with Article 4(1) of the GDPR, any information relating to an identified or identifiable natural person (hereinafter referred to as "data subject"). An identifiable natural person is one who can be identified, directly or indirectly, in particular by reference to an identifier such as a name, an identification number, location data, an online identifier or to one or more factors specific to the physical, physiological, genetic, mental, economic, cultural or social identity of that natural person. This can be, for example, information about where a person is insured, lives or how much money he or she earns. It does not matter if the name is mentioned. It is sufficient that one can find out which person it is.

• *"Special categories" of* personal data, according to Article 9(1) of the GDPR, are data revealing racial or ethnic origin, political opinions, religious or philosophical beliefs, or trade union membership, as well as the processing of genetic data, biometric data uniquely identifying a natural person, health data, or data concerning a natural person's sex life or sexual orientation.

• *"Health data" means,* pursuant to Article 4(15) of the GDPR, personal data relating to the physical or mental health of a natural person, including the provision of health care services, revealing information about that person's health status.

• *"Processing" means,* pursuant to Article 4(2) of the GDPR, any operation or set of operations which is performed upon personal data, whether or not by automatic means, such as collection, recording, organization, filing, storage, adaptation or alteration, retrieval, consultation, use, disclosure by transmission, dissemination or otherwise making available, alignment or combination, restriction, erasure or destruction.
