For young post-doctoral researchers in all areas of the humanities, social sciences or cultural studies for preparing an application for third-party funding or finishing publications on the basis of their doctoral thesis

Funding period: 3 - 12 months

Deadline for Applications: 15 May 2018

RESEARCH STAY IN ATHENS

For doctoral candidates and post-docs from archaeology, ancient history, epigraphy, numismatics, philology, classical building history, Byzantine studies or Modern Greek studies, for a research stay in Athens

Funding period: 1–9 months

Deadline for Applications: 10 September 2018

DOC-TEAM

For groups of 3 - 4 doctoral candidates from at least two different disciplines of humanities, cultural studies or social sciences cooperating across discipline boundaries

Funding period: 36 months

Deadline for Applications: 31 October 2018

DOC

For doctoral candidates in Austria from all areas of research who finished their Diplom or Master degrees not longer than two years before application

Funding period: 24 - 36 months

Applications can be submitted at any time (no deadline), two awards meetings per year

L'ORÉAL AUSTRIA

For female doctoral candidates and young female post-docs in the fields of medicine, mathematics, natural and life sciences, for finishing their doctoral thesis or preparing an application for third-party funding

Funding period: 6–12 months

Deadline for Applications: 1 March 2018

RESEARCH STAYS IN ROME

For doctoral candidates and young post-docs from law, history, art history, ancient studies, philology, musicology or ecclesiastical history, for a research stay in Rome

Funding period: 1–9 months

Deadline for Applications: 1 March 2018

CHEMICAL MONTHLY FELLOWSHIPS

For doctoral candidates in all areas of chemistry for finishing their dissertation at a university in Austria

Funding period: 6 –12 months

Deadline for Applications: 16 April 2018

MAX KADE

For scholars and scientists (up to 10 years after completion of their doctorate/PhD) in all areas of research for a research stay in the USA

Funding period: 12 months

Deadline for Applications: 2 May 2018

AWARDS 2018

NATURAL SCIENCES, MEDICINE AND MATHEMATICS

KARL SCHLÖGL AWARD

For an outstanding doctoral thesis in any field of chemistry, finished at a university in Austria no longer than two years before the application deadline.
Amount of the award: 4.000,- Euros
Deadline for Applications: 15 March 2018

OTTO VOGL AWARD

For an outstanding master thesis in any field of chemistry, finished at a university in Austria in the year before the application; applicants must intend to complete a doctorate or PhD in Austria.
Amount of the award: 5.000,- Euros
Deadline for Applications: 15 March 2018

HANS AND WALTER THIRRING AWARD

For outstanding research achievements in all areas of physics; nominees must have received their PhD from an Austrian university or must be working at a university or research institution in Austria at the time of their nomination.
Amount of the award: 4.000,- Euros
Deadline for Nominations: 16 April 2018

EDMUND AND ROSA HLAWKA AWARD

For outstanding research in the fields of number theory and geometry, especially in the theory of uniform distribution and the geometry of numbers; nominees must be Austrian citizens and should not be older than 45 years.
Amount of the award: 4.000,- Euros
Deadline for Nominations: 16 April 2018

AWARD FOR PALAEOBIOLOGY

For outstanding research achievements in the area of palaeobiology, esp. functional morphology, palaeo-ecology, evolutionary morphology, etc.; applicants must be Austrian citizens.
Amount of the award: 3.700,- Euros
Deadline for Applications: 16 April 2018

NEW WALTHER E. PETRASCHECK AWARD

For outstanding research achievements in the field of mineral resource research (such as mineralogy, geology, economic geology, geophysics, mineral processing); applicants should not be older than 35 years.
Amount of the award: 4.000,- Euros
Deadline for Applications: 16 April 2018

IGNAZ L. LIEBEN AWARD

For scientists (not older than 40 years) who have been working in Austria, Bosnia-Herzegovina, Croatia, the Czech Republic, Hungary, Slovakia or Slovenia for the last 3 years and have accomplished outstanding research achievements in the fields of molecular biology, chemistry or physics.
Amount of the award: 36.000,- US-Dollars
Deadline for Applications: 30 April 2018



HUMANITIES, CULTURAL STUDIES AND SOCIAL SCIENCES

DISSERTATION AWARD FOR RESEARCH ON MIGRATION

For doctoral candidates at a university in Austria from all areas of social sciences, humanities or law who are working on a dissertation project dealing with (forced) migration, the integration of migrants or the changes in societies because of migration.
Amount of the award: 4.000,- Euros
Deadline for Applications: 15 March 2018

ANNIVERSARY AWARD OF THE BÖHLAU VERLAG VIENNA

For an outstanding scientific work (e.g. doctoral or habilitation thesis) in all areas of the historic sciences that has been published or accepted for publishing; applicants must be Austrian citizens and should not be older than 40 years.
Amount of the award: 4.000,- Euros
Deadline for Applications: 30 March 2018

RICHARD G. PLASCHKA AWARD

For outstanding research achievements in the field of Eastern European, East-Middle European or Southeastern European History; applicants should not be older than 40 years.
Amount of the award: 4.000,- Euros
Deadline for Applications: 30 March 2018

ROLAND ATEFIE AWARD

For an outstanding doctoral thesis in the fields of philosophy, theology or indology, finished at a university in Austria no longer than two years before the application deadline.
Amount of the award: 4.000,- Euros

NEW GUSTAV FIGDOR AWARD FOR LAW, SOCIAL SCIENCES AND ECONOMICS

In 2018, the award is granted for outstanding research achievements in the fields of Social Sciences and Economics; applicants should not be older than 40 years.
Amount of the award: 4.000,- Euros
Deadline for Applications: 30 March 2018

NEW GUSTAV FIGDOR AWARD FOR LINGUISTICS AND LITERARY STUDIES

In 218, the award is granted for outstanding research achievements in the field of Literary Studies; applicants should not be older than 40 years.
Amount of the award: 4.000,- Euros
Deadline for Applications: 30 March 2018

BADER AWARD FOR ART HISTORY

For doctoral candidates (not older than 32 years) and young scholars (not older than 40 years) who are working on a doctoral thesis or a research project dealing with painting and drawing in the period 1500 – 1750.
Amount of the award: 18.000,- US-Dollars
Deadline for Applications: 30 April 2018

INTERDISCIPLINARY

BADER AWARD FOR THE HISTORY OF NATURAL SCIENCES

For historians and natural scientists cooperating on a pilot project as the basis for a doctoral thesis or a research project, preferably dealing with the development or the effects of a scientific idea or problem.
Amount of the award: 18.000,- US-Dollars
Deadline for Applications: 30 April 2018
